This is a contract between DOGS LIVE HAPPY and the pet owner whose signature appears below (hereinafter called "Owner").

1. DOGS LIVE HAPPY hereinafter referred to as the "Kennel", agrees to exercise due and reasonable care to keep its premises sanitary and properly enclosed.

2. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the Kennel. And further agrees to pay all costs and charges for special services requested and all veterinary cost for the pet during the time said pet is in the care of the Kennel.

3. The Kennel does not assume and shall not be held responsible for any liability with respect the animal listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from boarding this animal, or any damages which may accrue from any other cause whatsoever including loss by fire, theft, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named animal during the term of this contract, whether this animal be on the premises of the Kennel or not, and the owner of said animal agrees hereby to be and is solely responsible for any and all acts of behavior of said animal at any time within the term and time of the contract. The responsibility and/or liability of the Kennel, in no event shall exceed the sum of Two Hundred Dollars (\$200.00) and the undersigned agrees to limit the responsibility to Two Hundred Dollars (\$200.00) for any and all damages sustained or suffered by reason of the boarding of this animal and said Kennel to the sum of Two Hundred Dollars (\$200.00) and no more, and agrees not to claim any damages against said Kennel of any nature whatsoever, either by way of contract, equity, negligence or otherwise, in excess of said sum.

4. The owner of the within named animal specifically represents that he is the sole owner of said animal and that there is not now any lien or mortgage against said animal.

5. The Kennel shall have, and is hereby granted, a lien on the animal for any and all unpaid boarding and/or other charges resulting from the boarding of said animal with the Kennel.

6. If the animal becomes ill, the owner shall be notified at once, collect, if possible, or such attempt shall be made to so notify the owner, and if owner does not immediately inform the Kennel regarding measures to be taken or if the state of the animal's health requires quick action, the right to call a veterinarian or to administer medicine or to give advisable attention within the discretion shall be taken for granted by Kennel, and such expenses being reasonable in amount shall be promptly paid by owner.

7. Any controversy or claim arising out of or relating to this contract shall be settled by arbitration in accordance with the rules of the American Arbitration Association. The arbitrator shall, as part of his award, determine an award to the prevailing part of the cost of such arbitration reasonable attorney's fees of the prevailing party.

8. This Contract contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, and assigns of the owner of the within named animal.

Submitting your pet with it's toy(s), bedding etc is at your own risk. The Kennel does not assume and shall not be held responsible for any lost or destroyed items provided by owner.

- _____ 4. I further understand, consent and agree that any problem or injury that develops with my Dog (s) while under the control of *Dogs Live Happy, LLC* will be treated by my own Vet. In the event my own Vet is not available or too far away (i.e. in an emergency) I agree to let the Vets and Staff at *BEST FRIEND/GATEWAY ANIMAL HOSPITAL* (Vet of Record) treat my dog. **I agree to assume full financial responsibility for any and all expenses involved in such treatment.**
- _____ 5. I recognize that there are inherent risks of illness or injury when dealing with animals. Such Risks include, but are not limited to, problems resulting from rough play and canine cough (doggy colds).

Deposit and Cancellation Policy (as of May, 01 2009)

PLEASE initial on every red line

_____ We require a valid credit card to book each overnight reservation.

SORRY we do NOT accept checks anymore.

_____ **ALL Boarding Fees ARE DUE at time of drop off and payable by Credit Card!**

_____ We require a \$50 deposit, **for each dog**, for ALL Boarding reservations of 5-9 nights at the time of booking. \$100 per dog for any reservations of 10 – 14 nights.

_____ Kindly give at least 48 hours (2 days) notice for a Boarding cancellation. Failing to cancel within the proper time frame will result in a full charge for the first night of the scheduled overnight stay (during non-holidays).

_____ **During holiday stays a deposit of 50% of the estimated total stay will be charged at the time of booking.** The deposit is fully refundable if proper cancellation notice is given.

_____ **During holiday stays**, we employ a 72 hours (3 days) cancellation policy. Failing to cancel within the proper timeframe for a holiday overnight stay **will result in forfeit of the deposit.**

What to pack, or not, for a "sleep over"

Food : WE PREFERE that you bring your own food to prevent upset stomach , allergies, etc

Please make sure that the food is in a re-sealable bag or plastic container with your pets name on it labeled with feeding instructions.

You can also pack each individual, daily meal in a Ziploc bag.

Feel free to bring treats which you can also purchase at our facility.

Make sure that special feeding instructions are written down for us.

Bedding : Comfy bedding will be provided for those who don't bring their own, providing that your dog is not prone to chewing.

You may bring your bedding from home as long as it is machine washable. Please NO mattresses or foam bedding.

Please be aware that sometimes bedding is chewed or destroyed when left. Toys may also be brought at your own risk.

Medicines will be administered as directed by a Veterinarian. If your pet takes meds easier in a special treat or peanut butter, please inform us of this

What NOT to bring for a "sleep over"

Please do NOT bring:

- Mattresses , stuffed beddings, pillows etc
- Any valuable items
- Food or water dishes
- Food bags larger than 5 lbs
